

EMERGENCY GRADUATION and LICENSING POLICY

As of February 5, 2021, the NJ Division of Consumer Affairs/NJ State Board of Cosmetology and Hairstyling has TEMPORARILY altered their procedure to become licensed. This is an emergency response to the back log of people waiting for a practical examination slot. The following is required in order to become licensed in the State of NJ during this timeframe.

Please follow these steps in order:

1. **Pass** written examination (PROMETRICS) 960hrs-Cosmetology & 480hrs-Skin
2. Complete graduation requirements IN ALL AREAS at Parisian:
 - Online Financial Aid Exit Counseling Tuition and/or Overtime Charges-
(*must be paid in full 2 weeks before graduating*)
 - Online Financial Aid Exit Counseling www.studentaid.gov
 - Career Placement Form
 - Graduate Survey
3. Obtain instruction on how to apply for temporary permit and license on exit interview with Mrs. Rika.
4. Obtain a job at a licensed salon, spa, barbershop, etc.
5. Work for a minimum of 30 days
6. Have the Salon submit the State required ATTESTATION:
 - The Attestation must state....you have worked under the EPL - Experienced Practicing Licensee's supervision for a minimum of 30 days; and
 - The Attestation **must** state....you have demonstrated practical skills at a level sufficient to meet standard of practice in this State in areas specified by the State of NJ . This information will be on the Attestation form and format.
 - These requirements can go back 3 years from 2/5/2021 for anyone that is still attempting to apply for their practical licensing exam.
 - These provisions will be ended once the State of Emergency is lifted as per the Division of Consumer affairs.

Again, please be aware that you will not be qualified if you have not completed all exit functions for graduation at this school.
