Emergency Relief Fund Reporting – Emergency Financial Aid Grants to **Students**

- 1. On 5/13/2020, Paul Mitchell the School Cincinnati signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.
- 2. Paul Mitchell the School Cincinnati received \$388,108 from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Student.
- 3. Paul Mitchell the School Cincinnati distributed the following amount of Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act;
 - 6/25/2020, \$237,716.15 was distributed to approximately 196 students as Emergency Financial Aid Grants under Section 18004(a)(1) of the CARES Act.
 - 7/01/2020, \$150,391.85 was distributed to approximately 124 students as Emergency Financial Aid Grants under Section 18004(a)(1) of the CARES Act.
- 4. 320 students have received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act.

Subject: Policy on distribution of CARES Grant funds to students

To address the pressing financial need of higher education schools and students due to the disruption of campus operations from coronavirus, Paul Mitchell The School received a grant in the amount of \$388,108 from the U.S. Department of Education. The funds must be used to cover expenses related to the disruption of campus operations due to coronavirus (including eligible expenses under a student's cost of attendance, such as food, housing, course materials, technology, health care, and childcare). Students attending campuses in Cincinnati and Toledo must meet the following criteria to receive funds from this grant:

- 1. Only students who are or could be eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965, as amended (HEA), may receive emergency financial aid grants. If a student has filed a Free Application for Federal Student Aid (FAFSA), then the student has demonstrated eligibility to participate in programs under Section 484 the HEA. Students who have not filed a FAFSA but who are eligible to file a FAFSA also may receive emergency financial aid grants. The criteria to participate in programs under Section 484 of the HEA include but are not limited to the following: U.S. citizenship or eligible noncitizen; a valid Social Security number; registration with Selective Service (if the student is male); and a high school diploma, GED, or completion of high school in an approved homeschool setting.
- 2. Must be currently enrolled in a Title IV eligible program as of March 13, 2020.
 - a. Students who took a "Leave of Absence" on or after March 13, 2020 are eligible.
 - b. Students who started in a Title IV eligible program after on or after March 13, 2020 are eligible.
- 3. Must be 18 years or over, or if younger, currently receiving Title IV assistance.
- 4. Must have a graduation date on or after March 13, 2020.

The school will distribute the funds in two (2) different separate disbursement and will divide the funds available equally among the students who meet the criteria listed above based on the date of disbursement. If the student does not cash the check within 90 days, the funds will then be disbursed to other eligible students.
