Emergency Relief Fund Reporting – Emergency Financial Aid Grants to Students

- 1. On 7.10.2021 Paul Mitchell The School North Haven completed and returned to the Department of Education the Certification and Agreement and the assurance that the institution has used, or intends to use 100 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.
- 2. Paul Mitchell The School North Haven was allocated \$171,400 from the Department of Education pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Student.
- 3. Paul Mitchell The School North haven distributed a total of 73 Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act, as follows;
 - \$85,700 was distributed to approximately to 73 students as Emergency Financial Aid Grants under Section 18004(a)(1) of the CARES Act.
- 4. *73 students received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act.

Subject: Policy on distribution of CARES Grant funds to students

To address the pressing financial need of higher education schools and students due to the disruption of campus operations from coronavirus, Paul Mitchell The School North Haven received a grant in the amount of \$171,400.00 from the U.S. Department of Education. The funds must be used to cover expenses related to the disruption of campus operations due to coronavirus (including eligible expenses under a student's cost of attendance, such as food, housing, course materials, technology, health care, and childcare). Students attending campuses at Paul Mitchell the School North Haven must meet the following criteria to receive funds from this grant:

- 1. Only students who are or could be eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965, as amended (HEA), may receive emergency financial aid grants. If a student has filed a Free Application for Federal Student Aid (FAFSA), then the student has demonstrated eligibility to participate in programs under Section 484 the HEA. The criteria to participate in programs under Section 484 of the HEA include but are not limited to the following: U.S. citizenship or eligible noncitizen; a valid Social Security number; registration with Selective Service (if the student is male); and a high school diploma, GED, or completion of high school in an approved homeschool setting.
- 2. Must be currently enrolled in a Title IV eligible program during the Application period between 3.22.2021-4.10.2021 Or Started their program in the 6.29.20 and 8.25.20 Esthetics programs
- 3. Must be 18 years or over, or if younger, currently receiving Title IV assistance.

The school will distribute the funds to each eligible student based on a "share" system as follows:

> 3 Shares: Student has been awarded a PELL Grant & Direct Loan

> 2 Shares: Student has been awarded a Direct Loan

1 Share: Student is a "Cash Pay"
