Certification and Agreement for CRRSAA Funds

Paul Mitchell the School - Little Rock and Paul Mitchell the School - Norman acknowledges that they have signed and returned the official Certification and Agreement for CARES Act funds to the US Department of Education on February 4, 2021 – which serves as formal acknowledgment and acceptance of subsequently awarded Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) funds under Section 314(a)(1).

Total Funds Received

Paul Mitchell the School East Bay has received \$446,769 in total funds pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students on February 27, 2021.

Eligible Students

The estimated total number of students at Paul Mitchell the School - Little Rock and Paul Mitchell the School - Norman eligible to receive Emergency Financial Aid Grants to students under Section 314(a)(1) of CRRSAA is 292 for Round 1 and 203 for Round 2.

Number of Grants Awarded

Paul Mitchell the School - Little Rock and Paul Mitchell the School - Norman has awarded 485 students grants under Section 314(a)(1) of the CRRSAA.

Amount of Grants Awarded

The total amount of Emergency Financial Aid Grants awarded to students under Section 314(a)(1) of the CRRSAA Act as of October 6, 2021 is \$446,769. The amount of funds that have been disbursed to students is \$446,771.04.

Application & Awarding Process

Round 1

Qualifying Students

All currently enrolled students as of March 11, 2021 or a graduation date on or after December 27, 2020. Students who withdrew by March 11, 2021 or before are not eligible.

Outreach Method

A message on the school messaging platform (Klassapp) and/or an email informing students that they were eligible was sent to the group above.

Award Methodology

To support equitable opportunity for the student body to receive relief funds and prioritize those with higher need, awards were granted as follows:

\$877.17 grant available to Pell and Direct Loan eligible students.

\$584.78 grant available to Pell or Loan eligible students.

\$292.39 grant available to non-Pell or non-Loan eligible students.

Disbursement

Grants were mailed to student via paper check, picked up by the student, or posted to student account at students request after receipt of student's acknowledgement and written consent.

Communication

Information for the grant and the application was communicated via Klassapp and/or email to all currently enrolled students on April 5, 2021.

Round 2

Qualifying Students

All currently enrolled students as of June 28, 2021 and not have withdrawn from before the day of disbursement.

Outreach Method

A message on the school messaging platform (Klassapp) and/or email informing students that they were eligible was sent to the group above.

Award Methodology

To support equitable opportunity for the student body to receive relief funds and prioritize those with higher need, awards were granted as follows:

\$1,243.92 grant available to Pell and Direct Loan eligible students.

\$829.28 grant available to Pell or Loan eligible students.

\$414.64 grant available to non-Pell or non-Loan eligible students.

Disbursement

Grants were mailed to student via paper check, picked up by the student, or posted to student account at students request after receipt of student's acknowledgement and written consent.
