To help you in your decision about whether to enroll in a course at Gene Juarez Academy, we want to inform you of the graduation, licensure, and employment rates of our students.

The National Accrediting Commission of Career Arts and Sciences (NACCAS) accredits Gene Juarez Academy. NACCAS has established minimum acceptable outcomes of 50% completion, 70% pass rate on state licensing exams and 60% placement of graduates.

NACCAS placed Washington State on the Restricted Variance List of States indicating that the COVID-19 Pandemic had significantly impacted the ability of our students to sit for licensure and/or obtain employment.

Graduation Rate: This is the graduation rate of students who were scheduled to graduate in 2021 who completed by 11/30/22. Students who enrolled but withdrew in the first 30 days for the Cosmetology Program or first 15 days of the Instructor Training Program are not considered as scheduled to graduate.

Exam Pass Rate: This is the passing rate of students scheduled to graduate in 2021 who took both the practical and written licensing exams and passed both exams as of 11/30/22.

Employment Rate: This is the employment rate of students who were scheduled to graduate in 2021. These graduates were eligible for employment and obtained related employment by 11/30/22. Graduates are considered eligible for employment even if they did not take the state exam or chose not to work in the field.

Yearly, Gene Juarez Academy is required by the U.S. Department of Education to disclose the retention and completion rates for students who are first-time post-secondary school attendees who enrolled at our school. Of the 107 first-time post-secondary school attendees who were enrolled between August 1, 2021 and October 31, 2021, 78 or 73% were still enrolled or graduated as of August 1, 2022. Of the 99 first-time post-secondary school attendees who were enrolled between September 1, 2019 and August 31, 2020, 50 or 51% completed their study of course within 150% of the normal time for completion as of August 31, 2022. Due to small population, details by race and/or gender could violate student privacy and is therefore not being disclosed.
